Turnarounds are kept away from hazard spots (blind bends, busy junctions, narrow access points, etc). Leg speeds and distance to Turnaround Points are dynamically revised on the ground depending on presence of unplanned encounters of traffic, fauna, flora, works, lighting or running route conditions.
